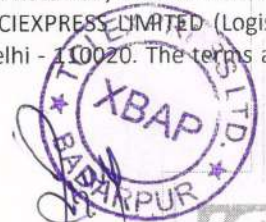

#### AGREEMENT FOR LOGISTIC SERVICES

This Agreement is entered on dated 19<sup>th</sup> October 2020 between M/s E-WASTE RECYCLERS INDIA a sole proprietorship firm, and having its registered office at, E-50, UPSIDC Industrial Area, 98 KM Stone, NH2, Kosi Kotawan, District Mathura, U.P. India and its Corporate office at A-46, Okhla Phase-1, New Delhi – 110020 and M/s TCIEXPRESS LIMITED (Logistic Company) having its registered office at C- 109 Okhla Phase 1, Okhla Industrial Area, New Delhi - 110020. The terms and condition of this Agreement are as under:-

1. Logistic Company agrees to provide the Logistics Services to **M/S E-WASTE RECYCLERS INDIA**.
2. Logistic Company sharing of warehouse as a collection points and safe and environmentally sound transport of e-waste.
3. The Logistic fee would mutually be decided by both parties as agreed on XDRO49620/19.
4. The other term of agreement would be as under:

WHEREAS The Recycling Company is the Dismantler of Electronic goods at its Unit at **E-50, UPSIDC Industrial Area, 98 KM Stone, NH2, Kosi Kotawan, District Mathura, U.P India**.

AND WHEREAS the Recycling Company Receive E-Waste/products for Dismantling from all collection center regularly;

AND WHEREAS the Recycling Company was in lookout for appointing a transport company, who can undertake the transportation of its E-Waste from its Collection Center regularly and contacted Logistic Company for the said purpose;

AND WHEREAS the parties have agreed to enter into an agreement herein contained.

NOW IT IS HEREBY AGREED BETWEEN BOTH PARTIES AS FOLLOWS

- (1) The Recycling Company appoints **M/S TCIEXPRESS LIMITED (Logistic Company)** having its registered office at **C- 109 Okhla Phase 1, Okhla Industrial Area, New Delhi – 110020** as its sole transport company for a period of **One Year** commencing from **19.10.2020 on yearly renewal basis** or an sporting its products to its Unit at **E-50, UPSIDC Industrial Area, 98 KM Stone, NH2, Kosi Kotawan, District Mathura, U.P, India** from its collection center situated in different cities of India. A list of the Collection Center along with their addresses and tentative quantity to be sent to them monthly has been given in the Schedule hereunder written.
- (2) The Transport Company agrees that it shall transport the products collected by the Recycling Company to its unit from the collection center mentioned in the Schedule hereunder written.
- (3) The Transport Company agrees that it shall make available to the Recycling Company every day whenever they required for transporting the Recycling Company's E-Waste, However.
- (4) The Recycling Company will pay to the Transport Company transport charges as per rate.
- (5) The manager of Recycling Company shall indicate to the transport company, so that loading of the E-Waste/products may start immediately.
- (6) The Transport Company undertakes that it will provide Transport/Trucks of good conditions with the drivers having valid driving licenses. The Associate/Manager of the Recycling Company will be authorized to inspect the condition of the transport/truck, permits, insurance books of each truck, up to date vehicle tax paid receipts and driving licenses of the drivers and the transport company will produce the said documents for inspection to the Associate of the Recycling Company whenever required to do so. If the Associate of the Recycling Company comes to the conclusion that any transport/truck is not of good condition or lacking in any other respect, he can require the transport company to take back the said transport/truck for which the transport company shall not be entitled to any charges. However, the Associate will intimate to the Transport Company the reasons for requiring the transport/truck to be taken back.
- (7) The products will be loaded by the workers of the Recycling Company. The products will be packed in big boxes, with suitable packing material, so that the E-Waste (products) may not be damaged in transit. The details of the E-Waste and the time required to reach its Recycling Unit will be given in the consignment note by the Recycling Company in four copies, which will be signed by the representatives of the Recycling Company and Transport

Company. The Recycling company will deliver two copies of the said consignment note to the transport company, and one copy to Recycling unit, to whom the products are sent and retain one copy with it

- (8) The Transport Company will deliver the E-Waste/products to Recycling unit and obtain delivery certificate/challan in duplicate from the Recycling unit. The E-Waste/products will be unloaded by the Recycling Company's workers. The Recycling Manager will receive packed boxes, from the transport company.
- (9) During the transport, the transport company's representatives will take proper care and precautions for the protection of the E-Waste/products, so that the E-Waste/products may be delivered to Recycling unit in good condition.
- (10) The Transport Company will issue COF (Certificate of Fact) for any damage and Recycling Company (EWRI) will Claim the insurance from insurance company by showing the COF.
- (11) The contract will be subject to the provisions of the Carriers Act, 1865.
- (12) In case any dispute, difference or question arises between the parties touching the construction, meaning or effect of this Agreement or any clause or thing herein contained or the rights or obligation of the parties hereto or their respective successors or assigns or any of the under this Agreement of otherwise howsoever in relation to this Agreement, shall be referred to two arbitrations, one to be appointed by each party, who shall appoint third arbitrator, who shall act the Presiding Arbitrator before taking upon themselves the burden of reference, and the provisions of Arbitration and Conciliation Act, 1996 and any statutory modification thereof for the time being in force shall apply to such arbitration.
- (13) The Agreement shall be executed in duplicate. The original shall be retained by the Recycling Company and the duplicate by the transport company.

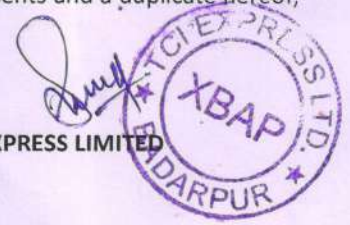
